Move on and rig up a cementing unit. TIH and pump 20 bbls water.  
Plug #1 bullhead down 2.875" casing from 1449' to 0' with 55 sxs Class B cement to fill the Pictured  
Cliffs perforations and cover the Fruitland and Kirtland tops.  
WOC and tag cement. Top off casing as necessary.  
Cut off the wellhead and set a P&A marker. RD and MOL.
