EnerVest Operating, L.L.C. respectfully requests to change plans to the procedure proposed on a NOI Sundry dated 5/18/12. Verbal approval was obtained 3-7-2013 from both the BLM and NMOCD to plug the Dakota and continue to complete the Mesa Verde. The amended procedure is outlined below:

Plug Back:

- TIH w/2 3/8" tbg to 7050'.

- Pump approx. 10 cu.ft. cmt on top of current CIBP & cmt @ 7051' to 6896' to plug off the Dakota.

- Pull up and pump balance plug from approx. 18 cu.ft. cmt. from 6220'-6020' to isolate the Gallup.

Set a CBP @ 5700'. Pump 26 cu ft cement on top of the CBP from 5700' to 5400' to isolate the Mancos.

Perforate the Mesa Verde from 5090' to 5318' and complete this well as a Mesa Verde-only producer.
