In accordance with Case # 14878, Order # R-13621, Energen Resources intends to downhole commingle the existing Blanco Mesaverde (72319) with Gavilan Pictured Cliffs production (77360). The existing MV perforations are 5394'-5480', 5504'-5680' and 5754'-5920'. Energen intends to set a bridge plug above the MV perforations, then perforate and fracture the PC around 3615'-3716'. Once flowback and cleanout is complete, the bridge plug will be drilled out, tubing landed the well will be put back on to production. Recommended allocation will be by the subtraction method following 60 days of stabilized production. Commingling will not reduce the total remaining productions value. The interest owners are identical for each zone. Rates will be reported to NMOCD-Aztec for final determination.



