Hole diameter: 6 1/8" production string diameter, 4 1/2" production string weight and grade: 11.6# SB80 LTC. Depth of 6 1/8" hole from 5865'MD to 12,575'MD. Float shoe at 12,573'MD and float collar at 12,555'MD. Production liner set from 5551'MD to 12,573'MD.
