Rick's Well No. 2 was drilled and completed as a Basin Fruitland Coal Seam well in the year 2000. A pipeline easement was obtained with approval from the Navajo Nation, BIA, and the BLM several years later. This allowed gas sales from the Rick's Well No. 2. The primary owner of the gathering line has changed ownership twice. Maralex permitted, designed and installed this gathering system and remains as a working interest owner in it. The primary owner of the line is now requesting what we believe to be high gathering fees for the transmission of our gas through the system. We are in negotiations with the the owner attempting to get this well back on line. The well is capable of producing gas at economic rates once a gathering agreement has been reached. Maralex requests permission to leave the well in a shut-in status until the agreement with the new gathering system operator has been obtained.
