

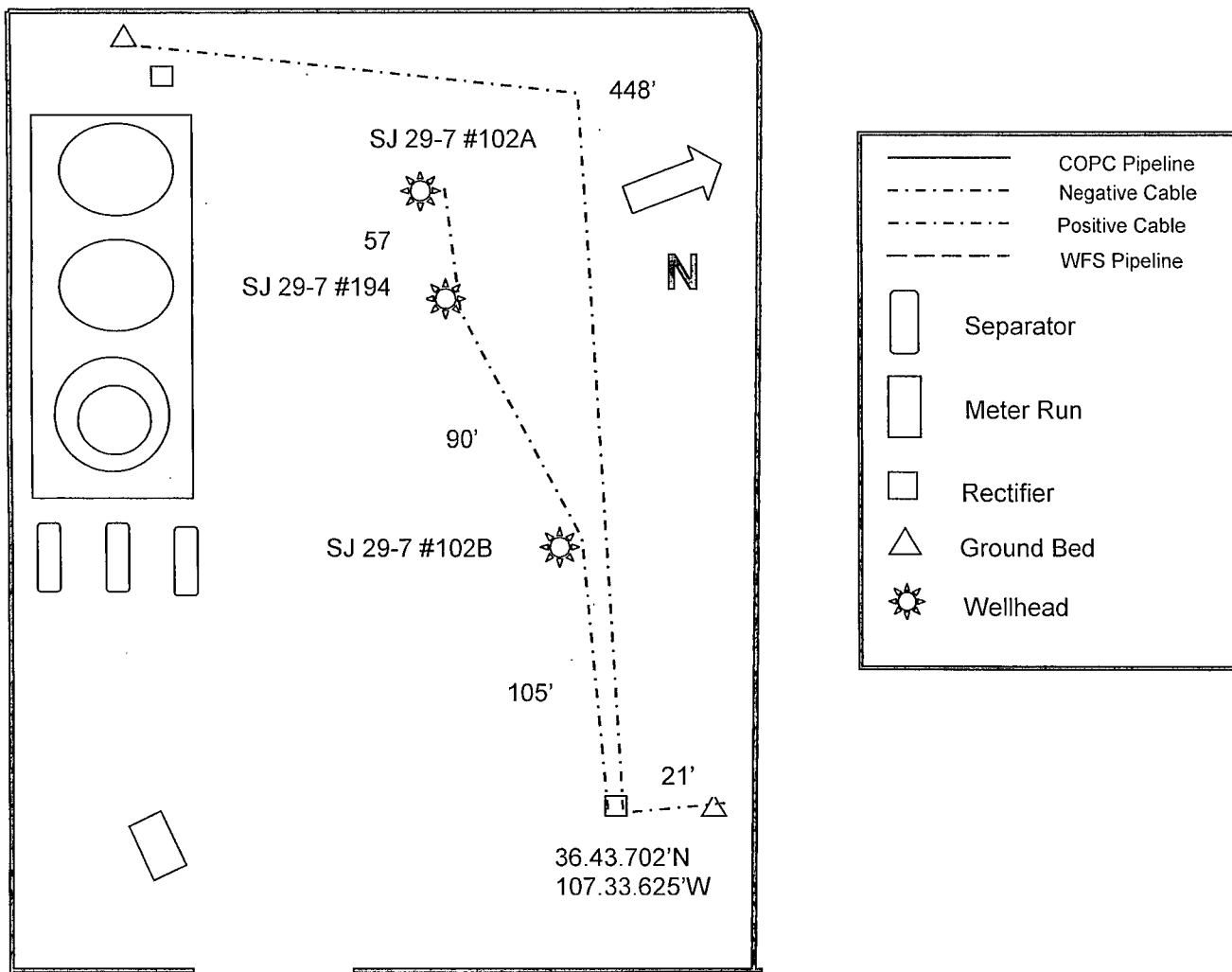

Drill ground bed approximately 123', east of #102B well head at staked location. Strip the existing dual well solar Upgrade to a multi well solar and set at staked location. Install cable to new ground bed and existing ground bed. Install Negative cable to the Solar control, San Juan 29-7 Unit #102B, #194 and #102A wellhead's at lengths below.
