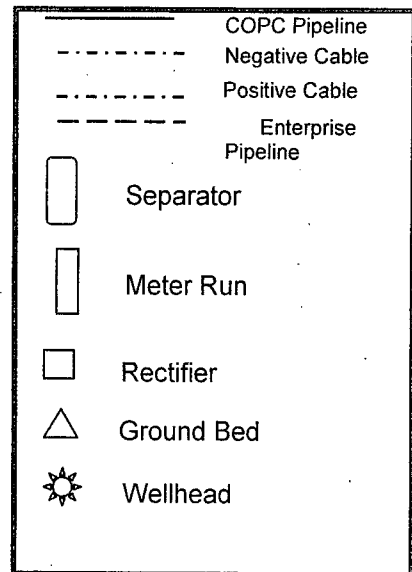
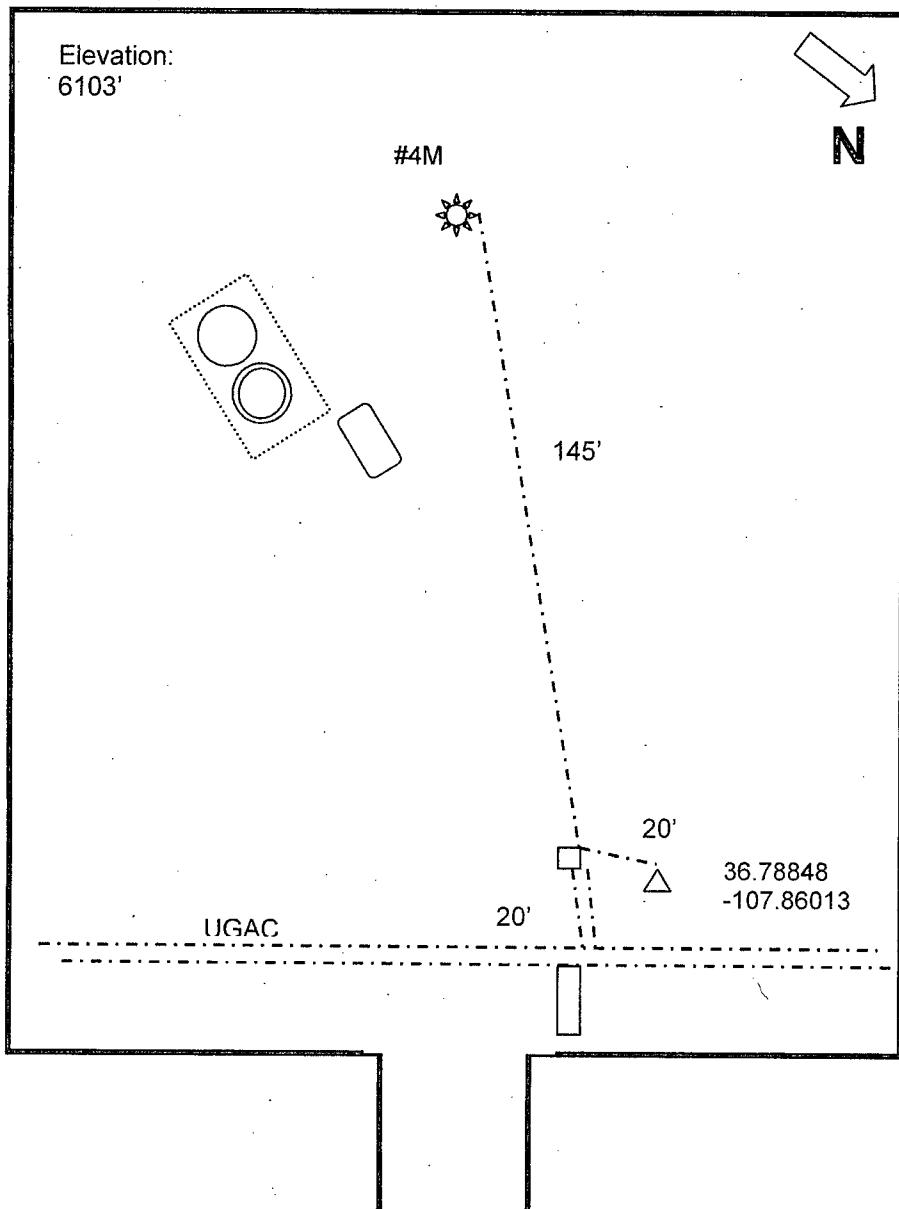

Unit letter D, S26, T30N, R10W, San Juan County, NM



Drill ground bed approximately 145' northeast of #4M wellhead at staked location. Install 40-16 rectifier at staked location and tie-in to UGAC at location entrance. Connect to groundbed and #4M wellhead at lengths below.

#4M Wire:

Positive: 20'

Negative: 145'

UGAC: 20'

Total Ditch: 185'
