
Black Hills Gas Resources (BHGR) had plugged back the Jicarilla 29-3-1 #2 to 3140' on May 14 2007; at which time the Jicarilla Apache Nation, Water Administration Department, requested the well be transferred to them so the could convert to a water well. As of today BHGR had not relieved any signed document relieving BHGR of the well. Therefore BHGR intends to plug and abandon Jicarilla 29-3-1 #2 and will submit the procedure within the next 60 days.
