An administrative review has been conducted on the following proposed Application for Permit to Drill (APD) submitted by Koch Exploration Company, LLC.

Bisti 2-1, State Lease No: ST NM VO-8293-0000. The proposed well is described as 660'FNL/660'FEL, located in Section 2, T24N, R13W, San Juan County, New Mexico. Included in the approved disturbance is a well pad containing 1.05 acres, more or less. This location is on the Navajo Nation Trust Lands and within the Navajo Indian Irrigation Projects (NIIP) designated boundaries.

Amended Resolution of the Resources Committee of the Navajo Nation Council No: RDCJN-05-11 passed on June 14, 2011, authorized the Navajo Nation Land Department to issue consent letters for APD's and Construction of Associated Ancillary Facilities. Consent letter dated April 5, 2013, approves the enclosed Koch Exploration Company, LLC's APD. Please note that the Resources Committee set certain terms and conditions which must be followed. The Navajo Nation Environmental Protection Agency also set specific terms and conditions which must be followed. Other required clearances from the Navajo Nation have been obtained and are on file.

NOTE: Navajo Nation Department of Fish and Wildlife set out specific conditional approval regarding this project. Project construction must avoid the Burrowing Owl (athene cunicularis) breeding season of 1 MAR – 15 AUG or a preconstruction survey will be required. The survey must include a buffer of 0.4 km (1/4 mi) from the edge of disturbance; (2) Project construction must avoid the Mountain Plover (charadrius montanus) breeding season of 1 APR – 15 JUL or a pre-construction survey will be required. The survey must include a buffer of 0.2 km (1/8 mi) from the edge of the disturbance.

We concur with approval of the above referenced application, provided enclosed Bureau of Indian Affairs and the Navajo Nation stipulations are adhered to and made a part of the drilling plan.
