Set surface casing string 5/12/13. Gelled freshwater mud system.

Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0-527'. Casing set from surface to 519'MD/TVD.

On 5/12/13 pumped 270 sks Type III cement + 0.253/sk Cello Flake + 1% Cacl2 + 1% FL52A. Circulated 20bbbls cement to surface. WOC 13 hours for surface casing.

Top of float collar at 473'. TOC at surface and BOC at 519'.

Tested BOP 5/13/13. Pressure held to 3000# for 30 minutes. Casing tested 5/13/13. Pressure held to 1500# for 30 minutes. No pressure drop.

Started drilling out cement at 480'MD/TVD on 5/13/13.
