5-09-13: Run 5-1/2" 17# L-80 production casing, set @ 7767'. Cement Stage 1 w/824.1 cu.ft. (410 sxs cmt, 2.01 yield), circulate 33 bbls good cmt to surface. Circ between stages.

5-10-13: Cement stage 2 lead w/504.81 cu.ft. (237 sxs cmt, 2.13 yield) and tail w/69.5 cu.ft. (50 sxs cmt, 1.39 yield), circulate 15 bbls good cmt to surface. Cement stage 3 lead w/877.56 cu.ft. (412 sxs, 2.13 yield) and tail w/69.5 cu.ft. (50 sxs, 1.39 yield). No agency reps on location for cmt job. RD, release @ 6:00 p.m.

Pressure test results on 5-1/2" prod. csg. & TOC to be reported on completion sundry.
