D. J. Simmons, Inc. has completed the following Plugging and Abandonment Procedure on the subject well:

3/8/2013 Move in and Rig Up well service unit.  
3/8/2013 Trip out of hole and lay down rods, pump and production tubing.  
3/8/2013 Load hole and pump 22 bbls water ahead at 5 bpm with 0 psi.  
3/8/2013 Mix and pump 10sx (11.8 cuft) lead cement with 2%CaCl<sub>2</sub>, 1/4#/sx cellophane to 15.6 ppg followed by 55 frac balls followed by 60sx (70.8 cuft) cement with 2%CaCl<sub>2</sub> and 1/4#/sx cellophane and 5 1/2 bbls displacement water.  
Wait on cement.  
3/9/2013 Rig up wireline. Tag cement at 357'. Perf 4 holes at 300'.  
3/9/2013 Unable to inject into perforations. Run tubing to 356'.  
3/9/2013 Mix and pump 37sx (43.66 cuft) 15.6 ppg cement with 2%CaCl<sub>2</sub> to spot down tubing. Lay down tubing.  
3/9/2013 Cut off wellhead and casings. Cement in casing at 27' and in bradenhead it is 70' from surface.  
3/9/2013 Fill strings with 13 sx (15.34 cuft) 15.6 ppg cement and cover with below grade dry hole marker at N-360 30.739', W-1080 07.362'.  
3/13/2013 Location clean and ready for remediation.

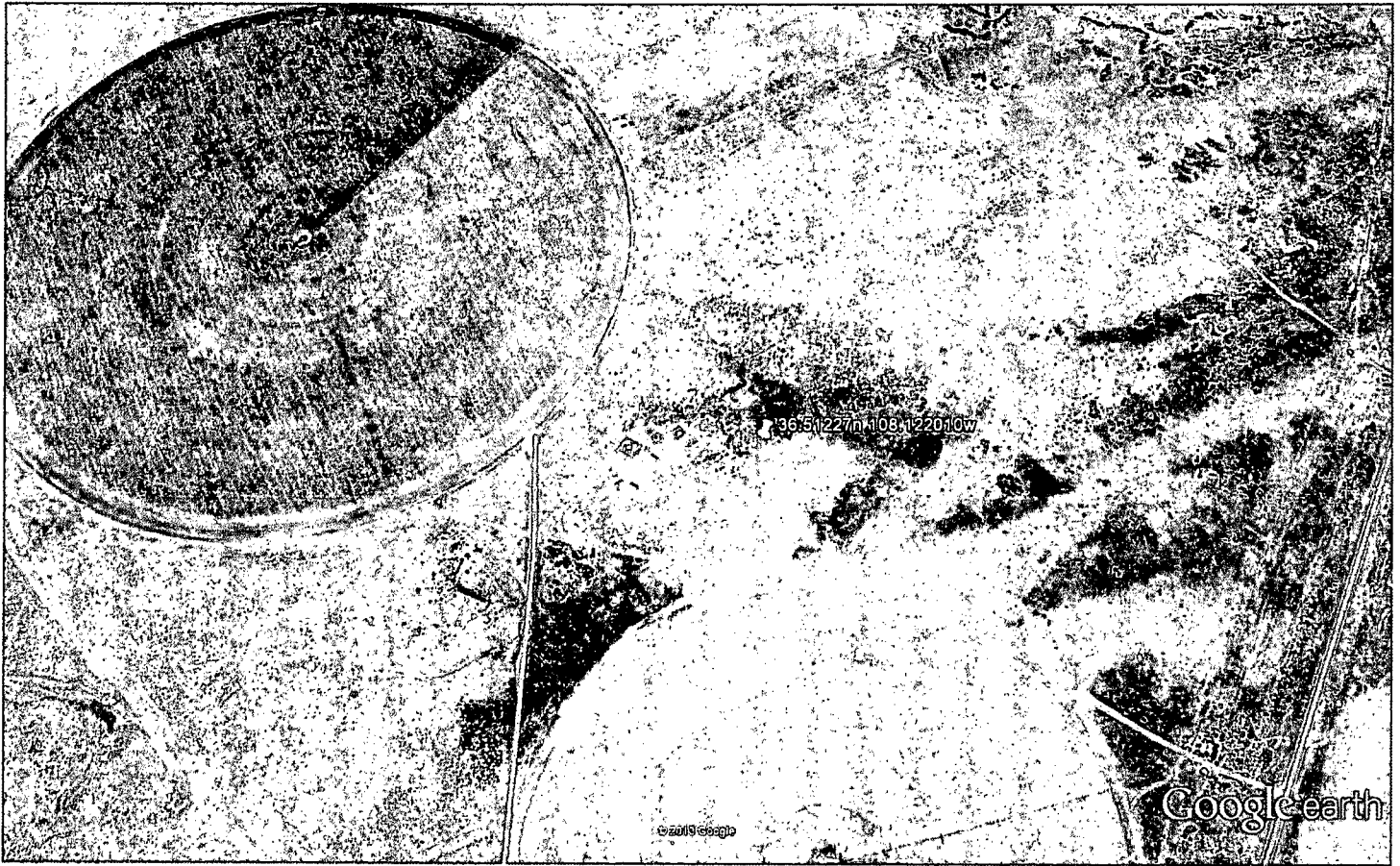
