Energen Resources identified two casing leaks from 3950'-4036' and 3216'-3277'. The planned procedure will be to set a cement retainer roughly 50' above 3950' and squeeze the lower leak, then pick up to set a balanced plug to squeeze the upper leak. Drill out cement and pressure test to 600 psi for 30 minutes.

Both the NMCD and BLM granted verbal permission to proceed with work.
