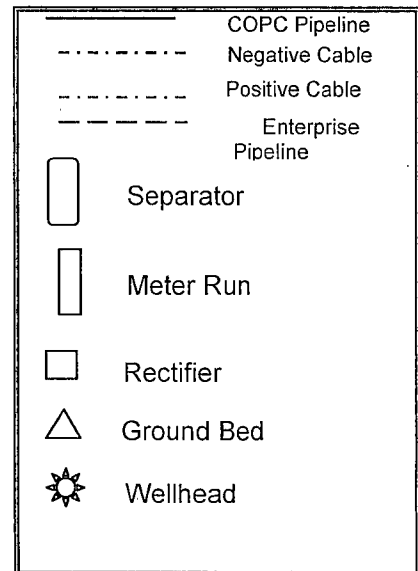
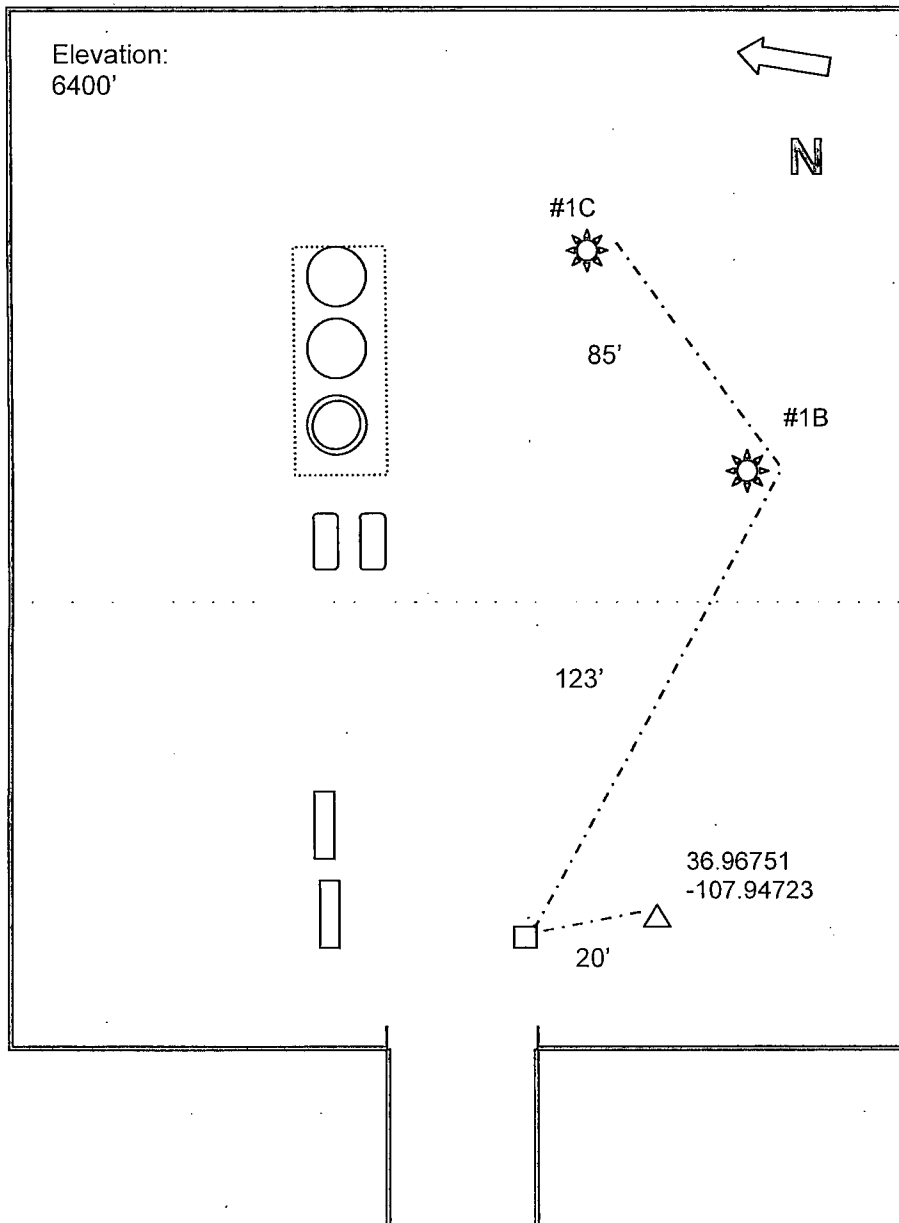

Drill ground bed approximately 123' northwest of #1B wellhead at staked location. Install a twin-well solar CP at staked location and connect to the #1C and #1B wellheads and groundbed. Abandon existing negative cable from the rectifier on the Primo Mudge #100-approx 1000' feet away,

Positive: 20'
