MIRU D&D rig spud well on 5/23/13, drilled 12 1/4" hole to 136' KB. Ran 8 5/8" 24# casing, landed at 135.90 KB. Ran centralizers on bottom joint, and every joint above. Pumped 100 sks of Premium cement + 2% CAC + 125lb/sk Poly-E-Flake, sks 117.0 cf (20.8 bbl) (wt 15.8#, yield 1.17). Dropped plug, displaced with 6.5 bbls fresh water. Returned 6 bbls cement to surface. WOC 20 hours.
