05/26/13 drilled 6 1/4" hole to 1150' TD KB. 5/27/13 Ran 4 1/2" 10.5# I-55 LTC casing, landed @ 1135.75 KB, top of float collar @ 1093.55'. Ran cement shoe on bottom, and ran centralizers on joints 7, 17, & 24. Used 20 bbls mud flush. Pumped Lead 85 sks LT Premium Cement + 5 lb/sk Kol-Seal + .125 lb/sk Poly-E-Flake + 2% CACL (159.8 cf 12.5#, yield 1.88). Pumped Tail cement, 55 sks Premium Cement + 1% CACL (63.8 cf, 15.8#, yield 1.16). Displaced w/ 17.46 bbls water and returned 6 bbls cement to surface. WOC 18 hours. 5/28/13 Cut casing, install tubing head, and test primary and secondary seals @ 2000#. Will pressure test 4 1/2" casing when ready to perforate. Released drilling rig.
