Logos Operating, LLC politely requests a pit closure extension of 30 days to allow for the remaining liquids in the reserve pit to evaporate due to the recent weather/rain. Closure of this pit will follow the closures of the reserve pits on the Logos 3 and the Logos 5.

Per the APD: the reserve pit must be closed within 90 days of the date of completion (completion date of 5/04/2013) and (pit closure date of 8/02/2013). The pit closure extension will end on 9/01/2013 which Logos expects to be sufficient time to eliminate the need for filtering the water from the mud and hauling the water to disposal.
