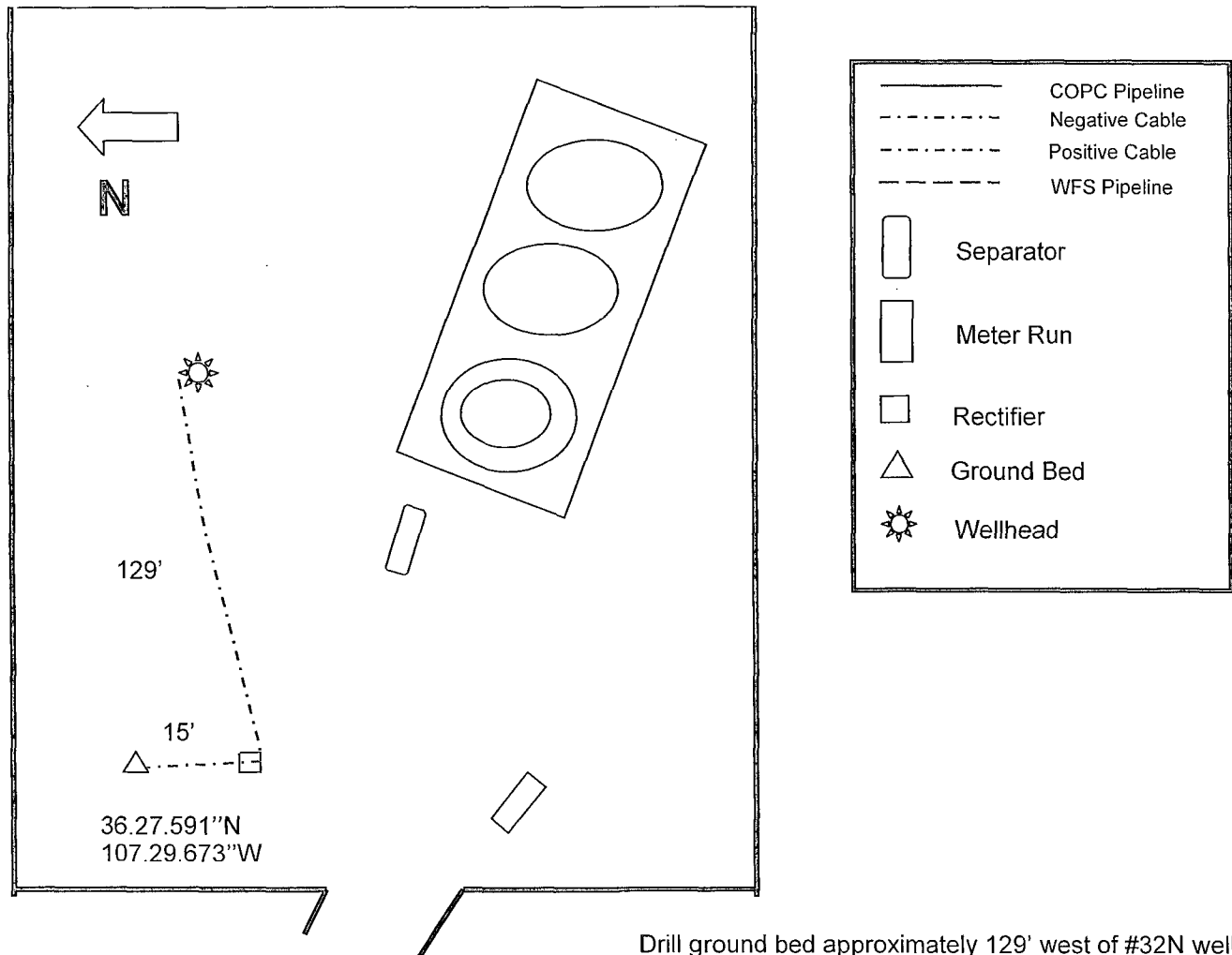

Drill ground bed approximately 129' west of #32N well head at staked location. Install single well solar at staked location. Install cable to new ground bed and to #32N well head at lengths below.
