Set intermediate casing string and cemented 8/21/13. Gelled freshwater mud system.

Hole diameter: 8.75". Casing diameter: 7". Casing weight and grade: 26# J55 LTC. Depth of 8.75" hole from 0 to 6380'. Intermediate casing set from surface to 6303'MD. Stage tool at 2004'TVD/Md. Top of float collar at 6258'MD. TOC at surface and BOC at 6303'MD.

Cement (pumped 8/21/13): Lead 501 sks Premium Lite FM + 3% Cacl2 + 0.25#/sk Celloflake + 5#/sk LCM-1 + 8% Bentonite + 0.4% FL-52A + 0.4% Sodium Metasilicate. Mixed at 12.1 ppg. Yield 2.13 cuft/sk. Tail 332 sks Type III Cement + 1% Cacl2 + 0.25#/sk Celloflake + 0.2% FL-52A. Mixed at 14.6 ppg. Yield 1.38 cuft/sk. Circulated 49 bbls to surface. WOC 7 hours.

Drilled out stage tool on 8/22/13. Tested casing and BOP 8/22/13 to 1500psi for 30 minutes and failed on first attempt. Called Ray, Troy Salyers, Brandon Powell, and Jim Lovato for futher instruction. Subsequent pressure test held to 1500 psi for 30 minutes. Received approval from BLM and State to proceed. No pressure drop. Started drilling out cement on 8/22/13.
