Elm Ridge Exploration Co LLC spud the above referenced well on 8-23-13. On 8-24-13 we drilled a 12 1/4" hole to 526' and ran 13 joints of 8-5/8" 24# J-55 casing to 526'. We then pumped 375 sks of Premium Class G cement. Circulated 25 bbls of good cement to surface. Pressure tested casing to 600 PSI for 30 plus minutes. ✓
Test was good.


