Elm Ridge Exploration CO LLC has drilled a 7 7/8" hole to a TD of 7600 ' as of 9-3-13. On 9-4-13 we set 179 jnts of 5 1/2" 15.5# J55 casing was set at 7593'. First stage cement was as follows: Lead with 250 sks Halliburton Premium Cement. Tailed in 200 sks of 50/50 POZ cement and circulated 30 bbls good cement to surface. Second Stage: Lead with 775 sks of Halliburton Premium Cement. Tailed with 50 sks of Premium Class G cement and circulated 60 bbls of good cement to surface. DV tool was set at 5073'. Released rig on 9-6-13.
