Set 15 external swellable casing packers for isolation of production string at the following depths: (1) 10,318' (2) 10,017' (3) 9,708' (4) 9,404' (5) 9,089' (6) 8,788' (7) 8,484' (8) 8,182' (9) 7,875' (10) 7,574' (11) 7,266' (12) 6,955' (13) 6,650' (14) 6,344' (15) 6,068'.
