It is intended to remove the packer set @ 4,029' & commingle the subject well in the Blanco Mesaverde (pool 72319) and the Tapacito PC (pool 85920). The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Proposed perforations are: MV 5,559' to 6,440'; PC 3,873' to 3,974' These perforations are in TVD.

BR will use some form of the subtraction method to establish an allocation for commingled wells.

Notification of the intent to commingle the subject well was sent to all interest owners via certified mail on 8/26/13. No objections were received.
