In reference to your letter dated September 16, 2013, XTO Energy Inc. was unable to complete the Plug and Abandonment started for this well on 3/5/2013 due to the request made by Brandon Powell w/NMOCD on 3/13/2013 to monitor BH pressures before proceeding w/P&A ops. The last four BH tests run were at 5 psi or lower, with the last BH test run on 9/25/2013, 24 hrs psi buildup 4 psi, bled off in less than 1 second. XTO Energy Inc. contacted Brandon Powell on 9/26/2013 with test results and Brandon Powell gave XTO approval to proceed with the P&A ops. A-Plus was contacted by XTO and as soon as A-Plus has a rig available XTO will complete the P&A of this well.

XTO Energy Inc. would like to request a 90 day extension to have adequate time to complete the plug and abandonment of this well and submit the subsequent report.
