First stage cement was as follows: Lead with 290 sks Halliburton Premium Cement. Tailed in 200 sks of 50/50 POZ cement and circulated 40 bbls good cement to surface. Second Stage: Lead with 710 sks of Halliburton Premium Cement. Tailed with 50 sks of Premium Class G cement and circulated 60 bbls of good cement to surface. DV tool was set at 4895'. Released rig on 9-23-13. ✓
