Cement (pumped 10/9/13): Stage 1 Lead: 371sks Premium Lite FM + 3% Cacl2 + 0.25#/sk Celloflake + 5#/sk LCM-1 + 8% Bentonite + 0.4% FL-52A + 0.4% Sodium Metasilicate. Mixed at 12.1 ppg. Yield 2.13 cuft/sk. Tail: 252sks Type III Cement + 1% Cacl2 + 0.25#/sk Celloflake + 0.2% FL-52A. Mixed at 14.6 ppg. Yield 1.38 cuft/sk. 20bbbs circulated to surface.

BOP tested 10/9/13 to 1500psi for 30 minutes. No pressure drop. Casing tested 10/9/13 to 1500psi for 30 minutes. No pressure drop. ✓

Started drilling out cement 10/10/13.
