In reference to the unlined permanent pit (UPP) for the subject well, a closure plan was sent to the NMOCD office in Santa Fe and accepted. The UPP was sampled and those samples analyzed in accordance with the standards set forth in the closure plan. All laboratory analysis returned with levels less than the criteria set forth in the NMAC. The UPP was back-filled with clean material and the area will be reclaimed along with the entire P&A'd gas well location. Upon completion of reclamation a C-144 will be sent to the NMOCD. The FFO BLM has the laboratory analysis on file and the UPP is ready for reclamation.
