BLM has required that the pumpjack be washed and cleaned: All liquids will be caught in a plastic lined hole, sucked out by a vacuum truck and disposed at a permitted disposal site.

Hydrocarbn impacted soils will be excavated and disposed at a permitted disposal site.

Sampling and re-sampling of impacted areas will occur.

The well pad will be re-contured so that flow from any release will move to the west side of the well pad.

A drainage and silt trap will be established on the west side of the well location.

The access road will have material brought in from the BLM Leased EDCO Chavez pit, N M Permit #128870.

The access road will be brought back to BLM Standards.

The motor will be repaired to stop the leak.
