Pumped 200 sacks of Type III Cement + 1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A, yield 1.38 cuft/sk, mixed at 14.6 ppg on 12/09/2013. Circulated 7bbls to surface, WOC 12.5 hours for surface casing.

Float collar at 479.8'. TOC at surface and BOC at 527.0'.

Tested BOP 12/10/13 to 3000# for 30 minutes. No pressure drop. Tested casing 12/10/13 to 1500# for 30 minutes. No pressure drop. ✓
