12/13/13 TIH, set 4.50" RBP @ 3967'. TOOH. TIH, set 7" pkr @ 3698'. PT csg & RBP to 1500#, good test. FWH to 3394' & set pkr. Established injection rate in PC perfs. Relax pkr. SI well.

12/14/13 Pull up on pkr, set @ 3394'. Pump 338 sx (399 cf) of Class B Neat cmt. WOC. SDFW.

12/16/13 Unset pkr & TOOH w/7" pkr. TIH, tagged TOC @ 3642'. Drill out cmt, fell through @ 3673'. Circ. clean. PT to 600#, fell to 320# in 1 minute. TOOH.

12/17/13 TIH open ended to 3687'. Establish injection rate. Pump 50 sx (59 cf) of Class B Neat cmt. SI tbg & increase squeeze pressure incrementally to 1500#, held 1.5 minutes, fell to 900# in 30 seconds & steadied at 880#. Walked pressure back to 1500#, held 5 min., no drop. Walked pressure to 2000#, 30 min, no bleed off.

12/18/13 TIH, tag TOC @ 3470'. Drill out cmt to 3618'. Circ clean.

12/19/13 Drill out cmt to 3696'. Circ. clean. PT holes & csg to 600#, 30 min, good test.

12/20/13 c/o to RBP @ 3967'. Unset RBP & POOH. TOOH w/4.50" RBP. c/o to 6117'. TIH w/2.375", 4.7#, J-55 prod tbg, set @ 5882'. Release rig.
