Perform MIT test on the casing, 4. Run CBL logs, 5. Perforate MV intervals (5135' - 5377'), 6. Fracture stimulate the Mesa Verde intervals via 3 1/2" N-80 frac string, 7. Evaluate MV intervals, 8. Remove frac string, CBP and return well to production as a MV / Dak dual producer. Well may be comingled DH (with R-11363) or surface comingled pending appropriate NMOCD approval (documentation would be provided).**


