13. Describe Proposed or Completed Operations:

12/5/13: TIH and set CR at 1104'. Pressure test tubing to 1000 PSI, OK. Sting out of CR. Pressure test casing to 950 PSI, OK. Establish rate of 2 bpm at 500 PSI. Spot plug #1 with 80 sxs Class B cement from 1483' to 928', squeeze 60 sxs below the CR and leave 20 sxs above the CR. Reverse circulate and TOH. Spot plugs (#2 & #3) with 65 sxs Class B cement from 434' to surface. RD and MOL.

12/18/13: Travel to location. Pump 32 sxs Class B cement from 60' to surface with poly pipe. Monitor well for 30 minutes. Set P&A marker. RD and MOL.
