First stage cement was as follows: Lead with 320 sks Halliburton Premium Cement. Tailed in 230 sks of 50/50 POZ cement and circulated 50 bbls good cement to surfac Second Stage: Lead with 680 sks of Halliburton Premium Cement. Tailed with 50 sks of Premium Class G cement and circulated 70 bbls of good cement to surface. DV tool was set at 4693'. Release Rig on 11-28-13.
