Surface commingling Blanco Mesaverde production will consist of the Florance P Well No. 39A API 30-045-21811 and Basin Fruitland Coal production will be from the Florance P Well No. 3S API 30-045-32427. The production from each well will be metered prior to commingling then the commingled production will flow into through the separator where the liquids will be removed. The commingled gas will then be sent through compression prior to entering the sales meter. Please reference the attached schematics reflecting the Proposed Surface Commingling Layout provided for your reference.

The working interest, royalty and overriding royalty interest owners in the subject wells are identical. The proposed commingling of production is to reduce operating expenses between the wells

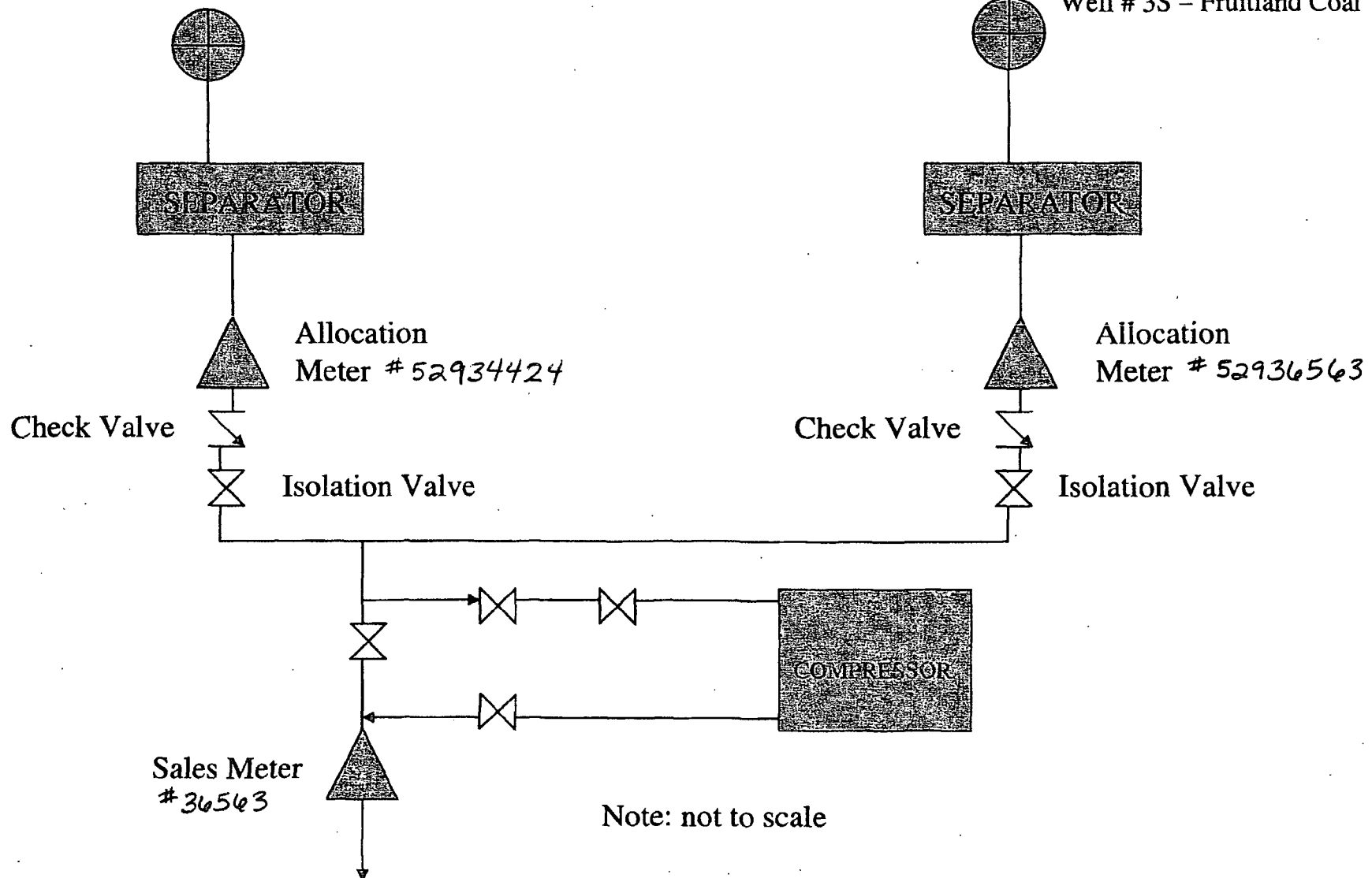
