Energen Resources intends to downhole commingle the Basin DK (71599) with the Basin Mancos (97232). The existing DK perforations are 5911'-6004'. The estimated Gallup perforations are 5065'-5362' at 3spf and will be stimulated in 2 fracture stages. CBL indicates good cement bond to 4835'. The well will be cleaned out to PBTD and produced through both zones.
