Logos Operating ran the 3rd cement squeeze job on 1/25/14, cement did not circ to surface. CBL ran on 1/26/14 showed TOC @ approximately 3240'. Logos plans to attempt the 3rd squeeze on the upper production casing with the following plan; leave cmt inside csg at 3290'. Shoot 3 squeeze holes at 2560', have the required amount of cement plus 30% excess onsite incase we are able to pump to surface. Attempt to pump approximately 314sx cement and circ cement to surface. WOC, drill out cement. Run CBL and PT squeeze holes to 500psi for 30min on a chart. Contact agencies with results and determine plan forward.
