4-3-2014: Rig up service unit. Pull pump and rods and lay down same. Rig up BOP and pull tubing. Run cast iron bridge plug on tubing and set at 1243. (Perforations 1278 to 1414). Pull tubing and lay down same. Load hole with 2% KCL water.

4-4-2014: Run MIT. Witnessed by NMOCD John Durham. Pressured up to 600 psi and held for 30 min, at end of 30 min pressure at 585. MIT passed.

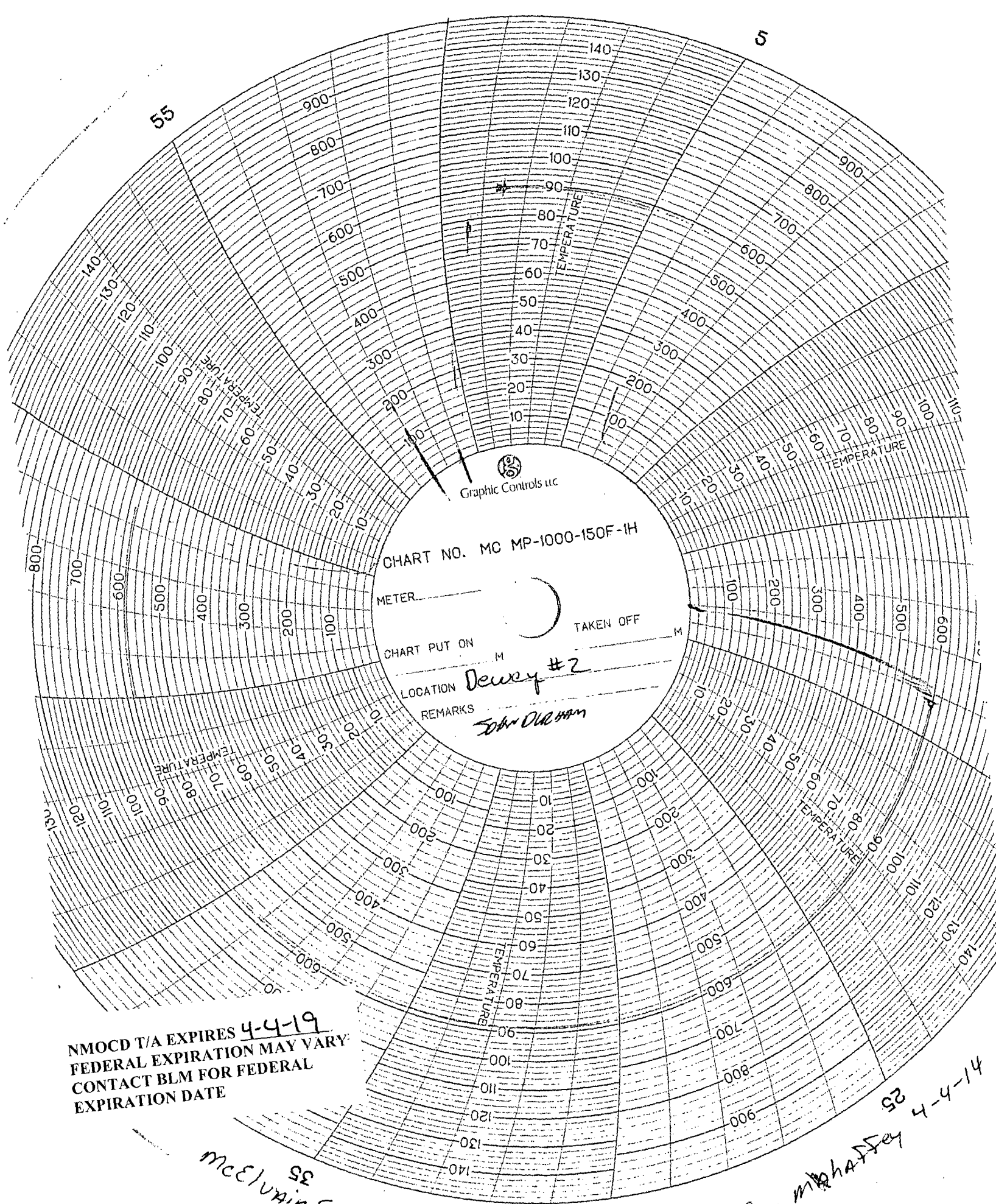
