

Describe Cause of Problem and Remedial Action Taken.*

Sometime after 1/27/2014 the ball plug on the drain valve associated with the AGT froze and broke. The ball valve did not hold the contents of the tank due to corrosion. The majority of the contents of the AGT released to the unlined secondary containment area. Further investigation will need to take place to determine the depth of impacts. Excavation will be the means of remediation.

Describe Area Affected and Cleanup Action Taken.*

Currently a barricade was put in place to prevent access to the area. Further investigation will occur to determine extent of impacts.
