

WPX Energy set surface casing on the well in the fall of 2011 with the intention of returning to finish drilling and completing in 2012. Due to the price of natural gas this was not economically feasible. We would request a one year extension to drill this well. This is still a viable project for WPX. Although this location has not had interim rehab completed, the location has been reseeded and the casing capped.
