The last production was near 225 mcf and 24 bwpd. Although gas prices have come up in previous months and the well is capable of production, economic production is still not viable. We request continued shut-in and "ready-to-run" status with annual approval pending economic improvement in order to recover the remaining reserves. The location and well are monitored and managed to conserve the investment, the resources in the reservoir and on the surface.
