McElvain Energy has elected to attempt a casing repair on the Ora #6 well. Currently the well has casing leaks from 2195 to 2270 and the DV tool at 3737 is leaking. Casing will be swedged out accomodate casing patches. Two casing patches will be run, the first one will be run on wireline across the DV tool and the second will be run on tubing across the casing leaks. An MIT of the casing from 6867 (sand, plug back depth) to surface will be run holding 500 psi for 30 min. The sand plug from 6867 to 8081 will be circulated out with air foam. Tubing will be run and set at +/- 7900 and the well be returned to production as a Gallup Dakota producer. Operations will commence once McElvain has received partner approval.

- Provide charted MIT results along with the Subsequent Report of Operations. If MIT fails, contact this office prior to returning this well to production.
