5-22-14: Rig up wireline truck and start perforating. Perforate from 7098'-7157'. Shot 180 holes total.

5-27-14: Rig up Halliburton and start acid job. Pumped 7000 gals 7 1/2% DI MCA acid w/ Musal, Iron Seq, Clay Stabilizer, Flowback Surf, and Friction Reducer.

5-29-14: Put well on a 1/2" choke and made 407 MCF gas. Tubing and casing pressure are 50 PSI.

5-30-14: Set 2 3/8" 4.7# J55 tubing at 7080'. 6-2-14: Move rig off location.
