Followed w/277 sks prem lite w/additives mixed at 12.1 ppg, 2.13 cu ft/sk yield lead cmt. Pumped 50 sks, type III cmt w/additives, 1.39 cu ft/sk yld & 14.6 ppg density tail cmt. Open stage tool @ 500 psi, shut down, circ 20 bbls good cmt to surface. Mxd and pumped 344 sks prem lite w/additives, mxd at 12:1 ppg, 2.13 cu ft/sk yld for lead & tail w/50 sks type III cmt mxd at 14.6 ppg, 1.39 cu ft/sk yld, SD, drop plug, bumped plug at 3110 psi, circulated 20 bbls good cmt to surface. RD Baker Hughes. RD and relsd rig at 06:00 5/20/14.
