Pumped 300 sacks of Type III Halcem Cement + 2% bwoc CaCl + 0.125 lbs/sk Poly-E-Flake, yield 1.17 cuft/sk, mixed at 15.8 ppg on 6/4/14. Circulated 25bbbls to surface. WOC 8 hours for surface casing.

Float collar at 456'. TOC at surface and BOC at 505'.

Tested BOP 6/4/14 to 3000# for 30minutes. No pressure drop. Tested casing 6/4/14 to 1500# for 30 minutes. No pressure drop. ✓
