

11/26/13 - RU Wireline and TIH w/ downhole camera and found 4 1/2" casing parted @ 1,321'.

11/26/13 - Notified Steve Mason w/BLM of parted casing. 7" casing is cemented to surface. Received verbal approval from Steve Mason to shut-in the well until Spring and evaluate a procedure going forward. We will move back on when Winter Closure is over in April 2014. Steve requested we check the pressures and if the well is flowing we can continue to flow it or kill it with kill fluid and we will Monitor the well over the closure period.
