Tail: 150skts Varicem .15% CFR-3 +.30% Halad (R)-9 + .01250 Poly-E-Flake, mixed at 13.5 ppg, yield 1.31 cuf/sk. 30bbbls circulated to surface, WOC 10.5 hrs

Drilled out DVT. Tested BOP 6/25/14 to 3000# for 30minutes. No pressure drop. Tested casing 6/25/14 to 1500# for 30 minutes. No pressure drop. Started drilling out cement 6/25/14.
