AFTER BRADENHEAD REPAIR ON MAY 21, 2014 IT WAS NOTICED THERE WAS A PROBLEM WITH THE BRADENHEAD. IT FLOWED A FOREIGN SUBSTANCE, WHICH CLEARED QUICKLY UPON OPENING THE VALVE. WITH NMOC D PERMISSION WE HAVE BEEN FLOWING THE FLUID TO A WATERTRUCK DAILY TO TEST VOLUME. THIS IS DONE ONLY DURING WORK HOURS SO THERE IS A MONITOR PRESENT AT ALL TIMES.

THE CBL DEMONSTRATED VERY GOOD CASING INTEGRITY AFTER THE REPAIR AND THE SURFACE CASING GOES DOWN TO 174', WELL BELOW THE FRESH WATER ZONE.

WE HAVE EMPLOYED ENVIROTECH INC TO DO ENVIRONMENTAL INVESTIGATIONS ON THE SITE. ENVIROTECH WILL BE DOING SEVERAL CORINGS TO GATHER SAMPLES AT VARYING DEPTHS. THEY WILL ALSO BE FINGERPRINTING THE LIQUID TO DETERMINE IF THE MATERIAL HAS ANY REFINED PRODUCT IN IT OR TO POSSIBLY IDENTIFY THE ZONE
