Conoco, the previous operator of this well, abandoned the Dakota formation by placing a CIBP at 6250' KB. The well was subsequently completed in the Fruitland Coal formation. The well bore rights were transferred to Thompson Engineering and Production, making a re-entry into the Dakota impossible. Plans for additional plugging operations will be submitted when the Fruitland Coal formation ceases production. ✓
