While consulting with BLM and NMOCD on Wednesday, September 3, 2014, verbal approval from Troy Salyers and Brandon Powell was given to place a cement block squeeze between the Chacra and Mesa Verde formations to stem the gas migration.

Enervest intends to shoot squeeze holes @ 4055' and attempt to pump Type III neat cement (mixed @ 15.6ppg, 1.18 yield). The amount of cement will be dependent on an ability to pump into annular spaces.

If this is not initially successful, further cement squeezes may be required by BLM and NMOCD.

BLM and NMOCD will be notified to witness final bradenhead test.
