Set 14 external swellable casing packers for isolation of production string at the following depths: (1) 10,004' (2) 9702' (3) 9398' (4) 9094' (5) 8786' (6) 8434' (7) 8091' (8) 7737' (9) 7396' (10) 7045' (11) 6690' (12) 6340' (13) 5987' (14) 5632'
